

SENATE JOINT RESOLUTION NO. 1—SENATOR PARKS

PREFILED JANUARY 23, 2009

SUMMARY—Proposes to amend the Nevada Constitution to replace the State Board of Pardons Commissioners with the Clemency Board appointed by the Governor and to require the Legislature to provide for the organization and duties of the Clemency Board. (BDR C-552)

SENATE JOINT RESOLUTION—Proposing to amend the Nevada Constitution to replace the State Board of Pardons Commissioners with the Clemency Board appointed by the Governor and to require the Legislature to provide for the organization and duties of the Clemency Board.

Legislative Counsel’s Digest:

- 1 Under the Nevada Constitution and existing law, the State Board of Pardons
- 2 Commissioners consists of the Governor, the justices of the Supreme Court and the
- 3 Attorney General. (Nev. Const. Art. 5, § 14; NRS 213.010)
- 4 This joint resolution proposes to amend the Nevada Constitution to: (1) replace
- 5 the State Board of Pardons Commissioners with the Clemency Board consisting of
- 6 nine members appointed by the Governor to carry out the duties currently carried
- 7 out by the State Board of Pardons Commissioners; (2) provide that at least five
- 8 members appointed to the Clemency Board must have experience working in the
- 9 criminal justice system; (3) require the Legislature to provide for the organization
- 10 and duties of the Clemency Board; and (4) require the Clemency Board to meet at
- 11 least quarterly. (Nev. Const. Art. 5, § 14)

1 RESOLVED BY THE SENATE AND ASSEMBLY OF THE STATE OF
2 NEVADA, JOINTLY, That Section 14 of Article 5 of the Nevada
3 Constitution be amended as follows:

4 Sec. 14. 1. ~~The governor, justices of the supreme~~
5 ~~court, and attorney general, or a major part of them, of whom~~



1 ~~the governor shall be one,] There is hereby created a~~
2 ~~Clemency Board.~~

3 2. *The Clemency Board consists of nine members*
4 *appointed by the Governor, at least five of whom must have*
5 *experience working in the criminal justice system. The*
6 *legislature shall provide by law for:*

7 (a) *The organization of the Clemency Board, including,*
8 *without limitation, the qualifications and terms of the*
9 *members of the Clemency Board; and*

10 (b) *The duties of the Clemency Board and its members.*

11 3. *The Clemency Board* may, upon such conditions and
12 with such limitations and restrictions as they may think
13 proper, remit fines and forfeitures, commute punishments,
14 except as provided in subsection ~~[2.]~~ 4, and grant pardons,
15 after convictions, in all cases, except treason and
16 impeachments, subject to such regulations as may be
17 provided by law relative to the manner of applying for
18 pardons.

19 ~~[2.]~~ 4. Except as may be provided by law, a sentence of
20 death or a sentence of life imprisonment without possibility
21 of parole may not be commuted to a sentence which would
22 allow parole.

23 ~~[3.]~~ 5. *The Clemency Board shall meet at least*
24 *quarterly.*

25 6. The legislature is authorized to pass laws conferring
26 upon the district courts authority to suspend the execution of
27 sentences, fix the conditions for, and to grant probation, and
28 within the minimum and maximum periods authorized by
29 law, fix the sentence to be served by the person convicted of
30 crime in said courts.
